




COURSE SCHEDULE FOR TRADITIONAL SEMESTER COURSES

STUDENT EVALUATION

The course has 15 weeks of required weekly discussion forums and 6 assignments. Discussion Forums are worth 30% of your grade. Assignments 1-5 are worth 25% of your grade. Assignment 6 – a Critical Research Paper (due in 5 phases) – is worth 45% of your grade. Letter grades are awarded based on the total number of points achieved.

Detailed evaluation criteria for each assignment will be clearly delineated on the assignment instructions.





Discussion forums will be evaluated based on both 1) meeting the required number of posts in discussion forums each week and 2) meeting the criteria of the discussion question.

Late assignments will be dropped by one grade for each day they are late. Extensions can be arranged in advance by contacting the instructor on an as need basis for medical reasons only.

Learning objectives for the course include:

- Awareness of a selection of well-known contemporary architects and architectural writers
- The ability to analyze and articulate current issues facing the profession and discipline of architecture
- The skills to make connections between concepts and form, written ideas and built projects
- An in-depth understanding of the relationship between culture and architecture
- Greater understanding of issues surrounding globalization, urbanism, research, digital technologies, landscape and infrastructure
- The ability to articulate coherent and well-researched arguments on complex architectural concepts
- Familiarity with preparing a Power Pont presentation

These objectives will be evaluated through discussion forums, quizzes, papers, and presentations throughout the course.

INSTRUCTIONAL METHODS AND COURSE ORGANIZATION

Blackboard Learning Environment – Blackboard at my.ltu.edu contains the syllabus, all assignments, reading materials, streaming videos, narrated PowerPoint mini-lectures, podcasts, written lecture notes, chapter quizzes, links to Web resources, and discussion forums. You will submit all assignments via Blackboard, and are expected to participate regularly in discussion topics. Please take time to familiarize yourself with the organization of the Blackboard site. You will want to check the site frequently for announcements reminding you of new resources and upcoming assignments.

Student/Instructor Conversations – Students keep in touch with the instructor via e-mail messages, telephone conference calls, and IM conversations.

Required Reading – Textbook chapters should be read according to the schedule outlined in the syllabus. Chapters will be discussed online.

Videos – A video will be posted each week on blackboard.

It is important for you as students to know what to expect from me as your instructor:


- I will be available to you via e-mail, and will promptly reply to your messages.

PRACTICAL GUIDELINES FOR CLASS LOAD EXPECTATIONS

A three-credit course generally requires at least nine hours per week of time commitment. Here are some practical guidelines to help schedule your time commitments for this online course:

- A 14-week semester (the Summer semester is compressed into 10 weeks) would require at least 126 hours of time commitment to successfully complete all readings, activities, assignments, and texts as described in this syllabus.
- You should reserve at least 6 hours per week to read the required textbook chapters and resources, participate in online discussions, review presentation materials, and work through online quizzes. This effort will total at least 84 hours over the course of the semester.
- You should organize your remaining time to roughly correspond with the point value of each major assignment. This means that you should plan to spend at least:
 - 8-9 hours preparing your case study review;
 - 24-40 hours working with your group on the three parts of your semester-long project;
 - 8-9 hours working on the various components of your reflective consolidation (final exam).

These guidelines may not reflect the actual amount of outside time that you - as a unique individual with your own learning style – will need to complete the course requirements. The number of hours each week will vary based on assignment due dates, so please plan ahead to insure that you schedule your academic, work, and personal time effectively. Participation (60 points)

Each student is expected to actively participate in online activities. There will be two required discussion forums each week. Participation in each discussion forums will be worth 2 points. 1 point will be given for participating. 1 point will be given for meeting the criteria of the discussion question. With 2 forums per week, over 15 weeks, discussion forums are worth 60 points. Discussion forums will focus on discussions of readings and providing commentary and critique of student papers and presentations.
